### **Jury Finds Man Guilty in Shooting Cases**

*VENTURA, California* – District Attorney Erik Nasarenko announced today that Glandros Danielle June (DOB 04/10/96), of Oxnard, was convicted of three counts of assault with a firearm, two counts of illegal possession of a weapon, and one count of discharge of a weapon with gross negligence. In addition, the jury found true all special allegations, including personal use of a weapon and personal infliction of great bodily injury. In a separate hearing, June admitted being out on bail in two earlier cases at the time he committed the assault with a firearm. Prior to trial, June pled guilty to four other charges.

On February 16, 2021, June fired a gun multiple times in an Oxnard shopping center parking lot during business hours. Restaurants, a gas station, and a Walmart store were open at the time. June fired multiple shots as bystanders fled the shooting. No one was struck by his gunfire.

On April 12, 2022, June traveled to a Ventura tattoo shop and shot three people within the business, seriously injuring two of his victims. June fled in a waiting car with five other people immediately after the shooting. One day later, Ventura Police Department officers arrested June outside a local restaurant. A subsequent search located a box of ammunition and a loaded firearm. Microscopic comparison of ammunition test fired through the weapon matched casings found at the crime scene.

Prior to trial, June pled guilty to crimes committed on December 18, 2021, that included possession of a large capacity magazine, illegal possession of a firearm, false information to a police officer, and delaying the investigation of a police officer. During an investigation of a stabbing incident in the parking lot at Levity Live, June gave Oxnard Police Department officers a false name. Officers discovered a firearm with an extended magazine concealed in June's backpack. June fled from the officers but was quickly apprehended.

June is scheduled to be sentenced on November 3, 2022, at 9:00 a.m. in courtroom 44 of the Ventura County Superior Court. June faces a maximum sentence of 36 years in prison.
